



What can we expect from this partnership?

All the partners will be involved in all phases of the project: Implementation, evaluation and follow up, as well as we should assume the following responsibilities:

Regarding participants and proffesionals:

a) From the Approval to the start date 1st Feb. 2015:

Invitation to youth workers, leaders and responsible of youth organizations, schenographic workers, set designers, Workers involved in Intelectual Disability World, potential employers,... Target group must be motivated and interested in the challenges and opportunities on the topic of employability in youth work.

b) From the Approval to 1st May 2015.

Recruitment and training to "Youth Meeting participants" in order to satisface the requests of the project: to enable them to develop a proactive team with skills and preparation for intercultural communication and networking in a European context.

c) During the **Youth Meeting and the Parade Event** (1^{st} -14th July and 6^{th} – 8^{th} September 2015) Support and advice from local and European participants in the project development. The aim is to involve them since minute 1 in all aspects: preparation, partnership, project development, communication with partners, visibility of the project...

d) As a multiplier agent we are responsible for motivating the human team (youth, workers, etc) to share the experience.

For it, they will have municipal resources such as Nova Onda TV (local radio station and online TV)

Regarding to the **Seminar and good practices exchange:**

The Seminar offers a learning approach that reaches out to the participants through a wide range of non formal education tools, coaching methods and techniques through learning by doing or learning by experiencing. All the attendees should prepare and share our existing practices and realities, as well as consult youth sector, disability sector, laboral sector and young people to summarize your local reality.

Other important aspects such as monitoring and evaluation, as well as the visibility and exploitation of results, will be coordinated by Europe Direct Albacete, but involve together all project partners. In this regard, we expect from our partners a special implication.
